District Coordinator(s) shall be notified immediately after a JV player's third Varsity game and the submitted rosters shall be amended accordingly.

10.8 Violations Any program found to be in violation of any of these eligibility rules will immediately be barred from all post-season play, and will forfeit the remainder of their regular season games. Egregious or repeat violations may result in expulsion of the program from the League.
